# TRADE SITE INFORMATION & CONDITIONS

**COMPULSORY TRADING HOURS**  
SATURDAY 25<sup>th</sup> February - 9.00AM - 5.30PM  
SUNDAY 26<sup>th</sup> February - 9.00AM - 4.00PM  
ALL TRADERS MUST BE TRADING BY AND DURING THE ABOVE HOURS

**NO DISMANTLING OF SITES UNTIL AFTER 4.00PM SUNDAY**  
**ALL TRADE SITES *MUST* EXIT GROUNDS AT CLOSE OF SHOW**

- **INSURANCE**

All traders *must have* and *provide a copy of a CURRENT Liability Insurance Certificate*.  
Traders selling food *must have and provide a Food Business Notification Number (BNN)*  
*ISSUED BY YOUR LOCAL COUNCIL*

- **TRESTLE TABLES**

Trade exhibitors are to provide their own lighting, tables / trestles (or by prior arrangement) etc.

- **POWER & AMPLIFICATION**

Electricity will be available in all areas for a connection fee.

All powered sites are to provide own extension cords **TO A MINIMUM LENGTH OF 50 METRES**

No private generators or amplification systems can be used without prior approval.

- **PRODUCTS / SALES**

**ONLY PRODUCTS LISTED ON TRADE SITE FORM ARE TO BE AVAILABLE FOR SALE**

Any products that are displayed and/or for sale, which have not been listed on trade site application form can be asked to be removed by the Angaston Show Society Inc.

- **NO RAFFLES, LOTTERIES, SALE OF BINGO TICKETS, ETC. IS ALLOWED**

Show bags and second hand goods will not be accepted by the Society without permission. No tents, booths or hawkers will be allowed on the grounds without permission of the Society and any person on the grounds illegally will be liable for prosecution.

The attached list indicates those items which are **NOT** allowed in any circumstances.....

- **TRADE SITE SET UP**

Trade Sites can be set-up on Friday 12.00pm-8.00pm or Saturday 6.30am-8.30am  
**NO SITES TO BE DISMANTLED BEFORE 4.00PM ON SUNDAY 26<sup>TH</sup> FEBRUARY 2012**

- **ELIGIBILITY**

All trade site applicants are granted permission to trade at the Angaston Show at the discretion of the Angaston Show Society Committee.

**No political groups are eligible to hire a trade site.**

- **SITE FEE REFUNDS**

Any refund of trade site fees is at the discretion of the Show Society Committee.

- **ANGASTON SHOW 2012 ADMISSION FEES**

**The hiring of a trade site does not entitle free admission.** Traders are therefore required to pay Traders Fee at a cost of **\$25.00** incl. GST, which gives tickets for 2 Adults per day. Extra persons staffing a trade site will require one ticket each day of attendance.

Extra tickets are available at a cost of **\$5.00** incl. GST each and must be purchased prior to the Show. Indicate number of tickets required on application form.

- **HOW TO APPLY FOR A TRADE SITE**

Simply complete the enclosed 2012 trade site application form including all costs incurred i.e. essential cost of site/s fee and compulsory Traders Fee, plus costs of power, camping and extra tickets.

Return the completed form and total calculated indebtedness **no later than 14<sup>th</sup> January 2012** together with payment. (**Credit card facilities not available.**) Sites will be allocated on a first come basis. (book early)

**The Angaston Show Society will start to allocate sites on receipt of full payment.** Once your site has been allocated you will receive your payment receipt, site plan showing your site number, car pass and tickets plus any additional tickets purchased.

- **CAMPING ON GROUNDS**

Any person intending to camp on the grounds must advise their arrival date to obtain permission and a camping pass **PRIOR TO ARRIVAL**. Permission will be granted at the discretion of the Show Committee and a camping pass will be issued on payment of fee. Any person found on grounds without a camping pass will be asked to leave and/or removed.

**NO CAMPING ON SHOWGROUNDS PRIOR TO FRIDAY 24TH FEBRUARY WILL BE PERMITTED**

- **CONDITIONS BREACH**

The Angaston Show Society Incorporated reserves the right in contravention of any of the above conditions or in the case of any perceived unacceptable or unethical behaviour to remove any trade site operator and/or trader staff from the Angaston Showground.
